## HOW TO REACH THE CONFERENCE VENUE

From Fiumicino Airport

- Public transport: Take the Leonardo Express train to Termini Railway station, then take the Metro line B (direction Laurentina) and get off at the "Basilica di San Paolo" station. Then it is a 5-minute walk to the conference venue.
- By taxi it takes about 30 minutes and it costs approximately €50. We recommend that you use the white taxis that have an agreement with the public transport system, which must ensure fixed fares from the airport: [Taxi - AEROPORTI DI ROMA - Aeroporti di Roma \(adr.it\)](#)

From Ciampino Airport

- Public transport: take the bus to Termini Railway station, then take the Metro line B (direction Laurentina) and get off at the "Basilica di San Paolo" station. Then it is a 5-minute walk to the conference venue.
- By taxi it takes about 30 minutes and it costs approximately €40. We recommend that you use the white taxis that have an agreement with the public transport system, which must ensure fixed fares from the airport: [Taxi - AEROPORTI DI ROMA - Aeroporti di Roma \(adr.it\)](#)

From Termini or Tiburtina Railway Station

- Public transport: take the Metro line B (direction Laurentina) and get off at the "Basilica San Paolo" station. Then it is a 5-minute walk to the conference venue.
- By taxi it takes about 30 minutes and it costs approximately €30.

## HOW TO MOVE IN ROME

### Public buses, trams and subway (Metro)

The ticket fare is €1.50 and is valid on the whole Rome urban network for 100 minutes from validation but allows only one journey on the Metro railway. Tickets can be purchased at tobacco shops and newspaper stands or at the ticket machines within the Metro stations. ### Taxi

Taxi service is always available day and night at taxi ranks just outside the exits of the airport. Besides it is for sure the fastest way to move around the city as taxis may drive on reserved lanes.
